

Study on the Optimization Strategy of Promoting the Reform of "Pipe Laying Service" in Heilongjiang Skiing Industry

At present, most of the skiing industry in Heilongjiang Province is constantly carrying out the reform of "pipe laying service" and effectively optimizing the industry.

2. Overview of "Pipe Laying Service"

"Deregulation service" mainly refers to the simple name of streamlining administration and delegating power, combining deregulation with management and optimizing service. The policy of "simplifying administration and delegating power" can not only effectively reduce the threshold of access, but also promote fair competition in the process of development. As early as 2015, the State Council implemented the strategy of "simplifying administration and delegating power". The Ministry of public security is carrying out effective reform by continuously deepening public security management [1]. Its supporting facilities are constantly absorbing the experience of previous construction, and fully integrating with the market in the process of development. As a result, the scale of ski resorts in China is constantly increasing. At present, most of Heilongjiang Province has a wide and deep management of skiing industry. Because of this, the investment channel of skiing industry becomes more and more narrow. In the process of development, it can not improve the service consciousness of the government.

4.2. The Internal Construction of Skiing Market Lacks Norms

Because the ski industry has been in the early stage of market development, the threshold of market access is low, and most of the government's supervision is weak. Therefore, Heilongjiang can not effectively carry out long-term planning in the process of development, so in a short time, there are too many ski resorts in Heilongjiang Province. Many businesses do not hesitate to make false propaganda in the process of competition, and cheat consumption in the process [2]. Therefore, most of the skiing enthusiasts in China do not ski in Heilongjiang. The skiing industry in Heilongjiang cannot develop better. Therefore, the competition mechanism of ski resorts in Heilongjiang province needs to be further regulated. We need to constantly regulate the economic order within the market in the process of construction.

4.3. Lack of Relevant Talents in the Skiing Industry

Because the skiing industry in Heilongjiang is very prosperous. So Heilongjiang has always been known as the cradle of skiers. Therefore, a lot of talents will flow into Heilongjiang Province.

Most ski resorts are unique nationwide, so a large number of talents with rich ski management have been trained. Most of the middle and high-level talents in ski resorts are from Heilongjiang Province. However, the quality of most internal ski talents in Heilongjiang is not good. The internal economy of Heilongjiang Province is constantly developing, and the brain drain is also constantly. Most of the internal personnel training concepts in Heilongjiang Province are relatively backward, and lack of the most basic talent introduction policies.

4.4. Relatively Insufficient Power for Internal Integration of Internet and Ski Resort

At present, there is still a certain gap between the development of Internet technology in Heilongjiang Province and other provinces. Including the construction of government service platform and information platform are not perfect. Most of the information and data in the service platform can not be effectively applied, and only regard the platform as information storage and data statistics machine. Not only the information between governments can not be effectively shared, but also the information within enterprises can not really play a role. In addition, most of the skiing industry has not been able to achieve better development, and the information on the network will be disorderly. It is difficult for the masses to handle affairs, and even in the process of work there will be a phenomenon of running away. In the end, it can not make the information in Heilongjiang province more public, and it will reduce the efficiency of enterprises in ski resorts.

5. Heilongjiang's Optimization Strategy for the Development of Skiing Industry under the Reform Path of "Pipe Laying Service"

5.1. Create the Business Environment of Skiing Market by Means of "Simplifying Administration and Delegating Power"

Only by testing the openness of market justice can we test the business environment of the market. Heilongjiang should first analyze the current situation of strong enemy competition and industrial decline to better promote economic development. When necessary, we need to start from the government's macro-control, and then effectively reduce the internal economic management of ski enterprises. Among them, the famous Yabuli ski resort has too complex internal components, and it will belong to different regions including electric power bureau, telecommunication bureau and Forestry Bureau. Finally, the government will make the market competition of private capital unfair in the process of competition.

Therefore, in the process of construction, only by constantly creating a fair and open business environment can we better promote the development of Heilongjiang ski industry. In the process of specific reform, state-owned assets need to withdraw from the operation of skiing market first, and effectively sort out the matters related to the examination and approval of reform, so as to better integrate the construction application procedures of most projects in the province. If necessary, non administrative licensing approval matters can be transformed into other types of legal approval matters [3]. In the actual development process, we can clarify the responsibilities between the government and the administrative department by clarifying the responsibilities of the government and the regulatory department, so as to better match.

5.2. Establish and Improve the Legal Guarantee System with the Goal of Combination of Release and Management

As mentioned above, there will always be insufficient legal system and structural imbalance in the industries in Heilongjiang Province. On the one hand, the lack of systematic policies in the skiing industry makes the skiing industry unable to develop better. On the other hand, because there is no effective supervision on the development of skiing industry, it makes enterprises

effectively exclude government supervision. Therefore, in the actual development process, we need to effectively enforce the law in accordance with reasonable law enforcement procedures, and then carry out comprehensive and intelligent supervision of the ski industry reform.

5.3. Effectively Integrate Skiing Industry and Internet

With the continuous development of the times, we need to use the Internet to improve the efficiency of ski industry development to make industry management more transparent. In the process of actual development, we can first reduce transaction costs of the system, and effectively promote the "Internet + government regulation + government services + information sharing" and a series of measures. In the process of actual development, we can also cooperate with other departments to build a shared ski industry information data resource platform. And through the use of data resource sharing to achieve online and offline integrated development.

6. Concluding Remarks

This paper makes a comprehensive analysis of the optimization strategy of promoting the reform of "pipe laying service" in Heilongjiang skiing industry. In order to attract more private capital to enter the legal system, Heilongjiang must continue to reform to manage a fair and just business environment. On the other hand, we should adopt effective human resource guarantee mechanism to develop effectively. Only in this way can Heilongjiang ski industry develop better.
