Bike sharing first downloads the app and registers users, who need to pay a different amount of deposit. Deposit: moBay 299 yuan / person, ofo 99 yuan / person, Xiaoming bicycle 199 yuan / person, Youbai bicycle 298 yuan / person Some shared bicycles can attract customers without deposit after saving enough users. Riding expenses are not deducted from the deposit, but from the prepaid fare.

Although bike sharing operators have a clear path for deposit refund, it is cumbersome. For example, Moby bicycle deposit is paid in 2-7 days, and the balance of riding fee needs to be refunded through customer service phone; the deposit of ofo users can be refunded in seconds, and the balance refund needs customer service assistance, which takes 1-7 days. Other bike sharing brands have similar refunds.

## 4. How to Solve these Problems in Bike Sharing Industry

First, sharing culture needs to be popularized. "Everyone for me, I for everyone" is a summary of the image of sharing economy. The sharing economy, because of the emerging industries, has no ready-made experience for reference, and the relevant social systems such as the integrity system are sound and coordinated. This requires us to speed up the popularization of sharing culture and improve the quality of citizens.

Second, the rules and regulations related to bicycle sharing industry need to be established and improved. For the healthy development of bike sharing, it is necessary to have a sound internal and external system support, and to strengthen the supervision of all relevant parties; for example, the management system of operating enterprises, reward and punishment mechanism, etc.; the government departments should guide and regulate the emerging forms of single car sharing industry according to the situation and local conditions, so as to disrupt the road order and urban management order For example, special parking areas should be provided, and the acts of vandalism and theft of bicycles should be punished according to law to enlarge the warning effect.

Third, the supervision mechanism should be strengthened (such as deposit). The scale of bike sharing market is becoming larger and larger, and the deposit and balance are a huge "capital pool". Where does the deposit for bike sharing go? This is a topic of concern to many bike sharing users. In addition, as a part of urban traffic, the relevant government departments should strengthen the supervision of bike sharing service providers and strengthen the management of the deposit of users. "

Fourth, the hardware and software technology of bike sharing needs innovation. Institutional, cultural and technological innovation is the premise to ensure the continuous development of a new industry. The same is true of bike sharing.
