3. Teaching Design of Ideological and Political Education in Foreign Accounting

3.1. Design Ideas

According to the ideological and political teaching design of the Foreign Accounting course, Teaching and learning are carried out in three stages, stage I, Before the class, Teachers will upload the courseware, test questions, case videos and other resources integrating ideological and political elements to the "Rain Classroom", Arrange the preview tasks, Students have preclass preview, Teachers should determine the focus of the lectures according to the students' feedback; In the class, Students use their mobile phones to scan the code and enter the classroom, Teachers can check the students' attendance through the "rain classroom", Use the bullet screen of "rain classroom", classroom test and voting and other functions to conduct classroom online interaction, Teachers integrate into ideological and political education during the lecture, Make the students build the mainstream values in the unconscious; after class, Teachers release ideological and political cases through rain class, students' learning and expansion resources and current political hot spots, Students consolidate and use their professional knowledge through group mutual evaluation of classroom assignments, At the same time, imperceptibly accept ideological and political education.

3.2. Integration of Ideological and Political Elements

Behind the knowledge points of Foreign Accounting contains rich ideological and political education elements. According to the professional characteristics and teaching objectives of foreign accounting, foreign accounting professional knowledge education and ideological and political education are organically integrated, and transfer positive energy to students with the help of case analysis, so as to cultivate students' rigorous, honest and dedicated professional quality. 3.4. Evaluation Mode

Improve the assessment and evaluation methods of foreign accounting courses, use multidimensional evaluation to show the ideological and political effects of foreign-related accounting courses, stimulate students' enthusiasm and initiative, improve students' participation in learning and stimulate students' interest in learning. The teaching effectiveness evaluation of Ideological and political education of foreign accounting course adopts the evaluation mode of combining online platform with offline classroom, diversified process evaluation and final examination evaluation, in order to assess the positive changes in students' ideological understanding and behavior. Online use of the "rain classroom" platform to assess students' attendance and classroom performance can feed back students' mastery of foreignrelated accounting knowledge on the one hand, and students' learning attitude, teamwork ability and sense of responsibility on the other hand [1], so as to test whether students can achieve the teaching objectives of foreign-related accounting courses. The scores of foreign accounting courses are composed of process evaluation and final examination evaluation, accounting for 50% of the total scores respectively. The content of process evaluation includes attendance, classroom performance, after-school homework and the completion of training projects. The embedded data analysis function of the "rain classroom" platform is used to realize the process evaluation of each student.

communication, Usually pay more attention to the current political hot spots, Note the accumulation of ideological and political materials, Participate in more ideological and political education training and learning, teaching and research activities, Communicate more experience and learn from each other with teachers in related courses, Inspire the inspiration of ideological and political teaching, To normalize the ideological and political teaching, Jointly improve the quality of classroom teaching; last, Play to the role of professional thinking and politics, Let ideological and political education not terminate with a course, Do it in the same vein, The ideological and political effect of the course continues to make efforts [2].
