Another set of data shows that in 2020,12315 platforms accepted 203.32 online shopping complaints, accounting for 28.04% of the total number of complaints and reports on the platform, and 184,100 cases were filed. Among them, live-streaming complaints with goods increased by 357.74% year on year, which is the worst-hit area of consumer complaints. Over the past year, live chaos, live with goods "rollover" example, the most typical is simba live with goods fake bird's nest events, from the initial not to admit, to the last sugar water as bird's nest sales fraud consumers, said return a compensate three, successively pay more than 6000 ten thousand yuan, thoroughly reveal the insider of live "live with goods" through the analysis and existing problems of the present situation of the industry, put forward optimization countermeasures for the sustainable development of the industry.
